- T.C.-3.3 Three countries only active, namely France,
 Netherlands and U.K. R. Jennings attended
 meeting in Kyoto.
- T.C.-3.5 Prof. Bassett attended the meeting in Kyoto.

 Much international interest in Prof. Flynn's

 work in this area.
- T.C.-4.5 Mr. McKnight attended the meeting in Kyoto. It appears that this committee is close to recommended practices for the lighting of marshalling yards, airport aprons and similar exterior lighting applications.
- T.C.-4.9 A written report will be sent to the Secretary.

 Mr. G. Cornish attended a meeting in Kyoto. Three sub-committees are attending to lighting development parameters, benefit parameters and cost parameters.

 There are problems in reaching general conclusions since each member country places different values on these parameters. It was reported that 75% of the total lighting power load in the Japanese residential sector are fluorescent lamps.

7. Matters raised by CIE Central Bureau

The Secretary remarked that a number of matters were mentioned in his report (Agenda item #3). Dr. Wyszecki reported that a discussion of the effectiveness of the CIE was in progress within the organization.

8. NRC Office of Lighting Research

Dr. Wyszecki reviewed the activities of the Office during the preceding twelve months and reminded members of the history of events culminating in the establishment of the Office and the Advisory Committee. A directory of Canadian organizations and individuals in Lighting R&D is being compiled.

9. CIE 19th Session, Kyoto, 1979

All Canadian delegates and representatives agreed that the Congress was superbly organized and well worth attending. Prof. Bassett has passed on these sentiments by way of letters sent to the Japanese Organizing Committee.

There was some discussion for improving the format of the quadrennial conference with perhaps separating in time the presentation of papers and the technical committee meetings.

10. Appointments and re-appointments

Prof. Bassett and Mr. Budde were re-appointed as Canadian representatives to the CIE Executive Committee (Moved: Mr. Cornish, Seconded: Mr. Labrecque).

It was the consensus of the Committee that the President send a letter to the President of the CIE, Prof. de Boer, regretting the events surrounding this year's presidential election and urging a reform of the voting procedure.

Secretary's Report to the Canadian National Committee of the CIE

October 1979

- 1. The 1979 annual dues of \$1756.92 (Cdn) for Canadian membership of the CIE were paid by the National Research Council in February 1979. Subsequently an increase in dues was notified and a further installment of \$169.84 (Cdn) was paid in April 1979. Total dues amounted to \$1926.76.
- 2. The purchase and sale of CIE publications is still being handled by CISTI and NRC publications respectively. Our current inventory list is attached.
- 3. CIE Bulletins Nos. 35, 36 and CIE Newsletters 5, 6, 7, 8 and 8/2 were received from the Central Bureau and distributed to members.
- 4. Three new CIE Publications were announced this year:
 - No. 41 Light as a true visual quantity: principles of measurement
 - No. 42 Lighting for Tennis
 - No. 43 Photometry of Floodlights
- 5. A significant amount of time was spent handling travel arrangements and passing on information relevant to the CIE 19th Session held in August in Kyoto, Japan.

The NRC Committee on International Scientific and Technological Affiliations provided financial support for Marion Bassett (President) and Peter Kaiser (Chairman TC-1.4) to attend the 19th Session.

- 6. The CNC/CIE was invited earlier in the year to comment on a proposal for Canadian international nongovernmental representation in scientific and engineering organizations. Report of President, CNC/CIE November 1979

- 1. A "Proposal for Canadian International Non-Government Representation" was received in January from Mr. C. Gauvreau, Secretary for International Relations, National Research Council. Comments from the CNC/CIE were requested on this document. A draft reply was prepared and approved by the CNC/CIE Executive Committee and sent to Mr. Gauvreau in May, 1979.
- 2. A letter of condolence from the CNC/CIE was sent by the President to the Polish National Committee on the death of Prof. Oleszynski a Vice-President of the CIE.
- 3. Letters of appreciation were sent, on behalf of the Canadian delegation to the CIE 19th Session in Kyoto, to the Japanese National Committee, the Japanese Organizing Committee and the Ladies Committee.

Report of CIE Executive Committee Members

November 1979

1. A letter was received in December 1978 from the CIE President, Dr. Guth, concerning the nomination of officers of the CIE for the next quadrennium. The Following candidates had the unanimous approval of the Board of Administration:

- 2. The financial report and draft budget of the CIE Treasurer were received in March 1979.
- 3. In May 1979 a letter was received from the Secretary of the Swiss National Committee, supported by the German and Austrian National Committees contesting the proposed slate of officers and proposing the following alternate candidates:

There were no nominations for the remaining ${\tt Vice-President}$ positions.

4. A letter was received in July, 1979 from the CIE President, commenting on the Swiss, German and Austrian letter. A detailed explanation for the Board of Administrations' proposed slate of officers was included and a list of nominees for all the CIE offices for the next quadrennium was given:

5. A letter was received from the CIE President in August concerning the CIE Bulletin. Brief articles on the organization and operation of the National Committees were requested. The Canadian National Committee has not responded to this request at this time.

- 6. Two meetings of the CIE Executive Committee were held at Kyoto. The following items were discussed.
 - 6.1 Reports were presented by the Secretary Dr. B. Steck and by the Treasurer, Dr. Terrien. The financial state of the CIE was very poor after the London session but this situation has been improved and suggestions were made in the proposed budget to maintain this favourable financial position. It was suggested that a part-time accountant be employed to improve the accounting procedures.
 - 6.2 Dr. Wyszecki, Chairman of the Action Committee gave a report and a "Proposed List of CIE Technical Committees and Study Groups presented for 1980-1983 Quadrennium". Canada will keep TC1.4 Vision and SG-G Global Radiation will become a sub-Committee of TC.1.7 Actinic Effects of Optical Radiation. TC.1.2 Photometry and Radiometry was held by Dr. C.L. Sanders until his retirement in the summer. Since a new chairman was not found it was suggested that it be combined with TC2.2, Detectors under Dr. Schanda.
 - 6.3 The German Democratic Republic was allowed full membership with voting rights at the second Executive Committee Meeting.
 - 6.4 The invitation by the Polish National Committee to hold the 1983 General Session in Warszaw, Poland was accepted. Mr. Kossakowski spoke about arrangements and suggested early May 1983 as a suitable date. The academic members had reservations about this choice so the time will be given further consideration.
 - 6.5 The proposed budget was passed with the proviso that the National Committees be advised of any problems with the Proceedings. There is to be a 20 per cent increase in fees for the first year and 10 per cent thereafter.
 - 6.6 A Proposal was made by Australia with regard to accounting procedures. This will be studied by the Board for financial feasibility.
 - 6.7 Germany requested that the method of assessing fees and budgeting be studied to achieve a more equitable distribution between countries.
 - 6.8 The following new officers of CIE were elected.
