Dr. Levy mentioned that his company was carrying out a technical and economic feasibility study on behalf of Public Works Canada concerning a national Testing and Evaluation Lighting Laboratory.

Dr. Rea informed the Committee that a Canadian Electrical Association fellowship in lighting had been established.

Dr. Pinkney outlined the status of the NAE lighting facility. (See enclosure.)

- 1. The 1981 annual dues of \$2,338.00 (U.S.) for Canadian membership of the CIE were paid by the National Research Council in February of this year.

Report of the President, CNC/CIE November 4, 1981

- 1. At the annual meeting of the CNC/CIE held in October 1981, the President was asked to write to the President of the National Research Council, Dr. L. Kerwin, about the prospects for the future of lighting research in Canada. A letter was sent on November 21st, 1980 and a reply was received on December 9th, 1980. Dr. Kerwin assured us that R and D in light and lighting was being considered in NRC's detailed research planning for the next few years. He was pleased to hear that the CNC/CIE was forming an ad hoc committee to monitor the lighting research needs of the lighting community in Canada and looked forward to receiving input from us to help NRC with its future R and D plans.
- A mid-term meeting of the Executive Committee of the CIE was held in May 1981 in Granada, Spain. The National Research Council very kindly supported my attendance at the meeting.

The proposed restructuring of the CIE was the major item discussed at this meeting, and it was very helpful to hear the views of all the other National Committees about the changes suggested. Many details of the proposals were very controversial and were to be discussed again by the Board of Administration and Action Committee before they were to be officially sent to the National Committees for their consideration.

Dr. Wyszecki has just returned from CIE meetings in Europe and will report on the present state of the negotiations.

There was also considerable discussion and controversy over a request from several countries (notably Australia) for the CIE financial accounts to be audited. A compromise trial audit will be initiated.

3. An invitation was sent to Mr. Franc Grum, President of the USNC/CIE to attend our annual meeting. Unfortunately Mr. Grum is not able to attend as he has a meeting in Washington.
